# 1 Introduction

# 2 Communication strategy


SPEEDIER's first newsletter was released in October 2019, and was sent to 22 subscribers.

# Welcome to SPEEDIER Project!

On June 18 and 19, SPEEDIER, a European project within the H2020 framework, officially kicked off with a meeting at the Tyndall National Institute in Cork (Ireland), hosted by the International Energy Research Centre (IERC). This 30 months project aims to address the barriers faced by Small & Medium Enterprises (SMEs) that prevent them from undertaking energy audits and implementing the recommended energy-saving measures. This is Horizon 2020 funded project and has as a total budget of €2,165,126.25



SMEs account for 12% of global energy consumption, but often struggle to implement simple energy saving measures due to a lack of in-house knowledge, expertise and resources. To address these issues, SPEEDIER (acronym for SME Program for Energy Efficiency through Delivery and Implementation of EneRgy Audits), will provide a self-financing outsourced energy management service to SMEs.



SPEEDIER is a highly innovative one-stop-shop solution that applies an integrated approach to energy management, providing information, advice, capacity building, energy auditing, financing, and implementation of energy efficiency solutions and monitoring of impacts. The consortium delivering this project is led by the IERC and consists of 6 Research and Technology Centres, 3 SMEs and 1 Non-Governmental Organisation (NGO).

SPEEDIER is expected to contribute European energy efficiency targets by saving approximately 8 GWh/year of primary energy, and 1,280 tCO2/year. Within the lifetime of the project, SPEEDIER will train more than 650 staff at SMEs across a range of sectors in the best practices of energy efficiency. The project will build capacity for ongoing roll out around Europe by training 50 SPEEDIER experts to deliver the

SPEEDIER Service.

# How do different countries approach energy audits?





To achieve the project aims, SPEEDIER will target groups of SMEs in 4 EU pilot regions: in **Spain**, the project will engage with SMEs based at a single business park to

demonstrate the advantages of clustering SMEs to give them better access to the economies of large scale projects; in **Ireland** and **Romania**, SPEEDIER will address SMEs in the manufacturing and hospitality sectors respectively; and in **Italy**, a more general approach of accessing SMEs from any sector via ESCOs will be tested.

As a first step the project team is currently reviewing existing projects, tools and policies related to energy auditing and implementation of energy saving actions in

SMEs to get a better understanding of the different approaches taken in each pilot country. This literature review will identify best practice examples, challenges faced and key learning points from past projects, which will help us to make sure the SPEEDIER Service is tailored the needs of its users. The final report will be published on our website in September.


# The results are in: Why don't more businesses undertake energy audits?

The SPEEDIER team recently conducted an online survey of SMEs and key stakeholders in the energy value chain to understand what prevents SMEs from undertaking energy audits and implementing energy efficiency recommendations. In particular we wanted to understand what they need from the SPEEDIER Service and how we can make sure that our SPEEDIER Experts can help them to manage their energy consumption. We received responses from 84 SMEs and 91 stakeholder across all the four pilot regions we are working in (Ireland, Italy, Spain and Romania).

The majority of the SMEs confirmed that they had not had an energy audit in the last five years (64%), did not have an energy manager (75%), had not developed an energy policy (63%) and had not set any targets for reducing energy consumption (52)%. Whilst this is not altogether surprising, what is interesting is the reasons that SMEs gave to explain the lack of action on energy and the differences between the pilot regions as shown in the pie charts below. For Irish respondents the main challenge is their lack of knowledge on which measures

are the most appropriate for their business and how to procure them. In contrast, for Romanian SMEs lack of finance is overwhelmingly considered to be the main barrier. In Spain and Italy, the responses are more evenly split between lack of finance, lack of knowledge, lack of time, the low priority of energy efficiency compared to other business needs and lack of control of the building premises. From this study we have learned that it is highly important to tailor the SPEEDIER Service to the requirements of each country.

What is the MAIN barrier to implementing energy conservation measures?



A further key finding from the surveys is that almost 70% of energy experts have not received any kind of local or national government support to support SMEs to deliver energy auditing or other kinds of energy efficiency support services. This indicates that although Member States are obligated to assist SMEs to undertake energy audits under Article 8 of the Energy Efficiency Directive (EED), such support schemes either do not exist, are ineffective or are not widely known about by energy experts. In time, the SPEEDIER Service could fill this gap and assist Member States to meet their objectives under Article 8 of the EED.

# SPEEDIER holds its first engagement events and focus groups

In November and December, 2019, the SPEEDIER project hosted four focus groups sessions in the chosen pilot regions (Ireland, Italy, Romania and Spain) where different stakeholders found out more about the project and were able to present their opinions on energy auditing in SMEs, including key barriers and risks that prevent from engaging with the SME market. These focus groups gave us a deeper insight into the status of the market in each pilot country and allowed us to ask more detailed questions than we were able to ask in the online surveys.

In parallel, several engagement events were organized by the consortium partners to showcase the project scope and to raise interest in SPEEDIER among SMEs and energy experts. 


FIGURE 3 SPEEDIER AUDITING TOOL ANALYSIS

# SPEEDIER supports SMEs to recover after COVID-19

SMEs around the world have suffered significant losses due to the impact of the COVID-19 pandemic. As Europe begins to emerge from lockdown, SPEEDIER will be used as a recovery tool for business to help them to improve cash flow by minimising their energy costs. SPEEDIER Experts will advise businesses and help them to access any available recovery grants. Covid-19 lockdowns have reduced the energy consumption of many businesses. SPEEDIER will help to maintain this reduced level of energy consumption by setting energy reduction targets and advising on how best to achieve them. Our project will be part of the "Green Recovery" enabling businesses to focus on minimising their environmental impact whilst maximising their profitability.

# SPEEDIER's response on Covid-19 impact

Although pilot site leaders and SPEEDIER Experts are not yet able to physically visit SME sites to carry out energy assessments, there is still a lot of work going on in the background. Pilot site leaders and SPEEDIER Experts have begun to work with SMEs remotely to carryout desktop energy assessments, and establish the baseline energy consumption for each business against which savings will be measured. The SPEEDIER consortium is utilising this


time to develop the training materials for SMEs, SPEEDIER Experts and SPEEDIER Trainers, which will now be delivered online as part of SPEEDIER Services.

The SPEEDIER team is also keeping close eye on the various Covid-19 recovery grants available in each pilot country to help businesses to recover from the unprecedented losses due to the Covid-19 pandemic.

# SPEEDIER's Sister Projects

SPEEDIER isn't the only H2020 project that is working with European SMEs to help them to improve their energy efficiency. <u>SMEmPower Efficiency</u>, <u>Innoveas</u> and <u>E2DRIVER</u> were funded under the same Horizon 2020 call as SPEEDIER and all projects share the same aim: to help SMEs to undertake energy assessments and implement the recommended energy conservation measures to reduce energy consumption and associated costs.

In early July these four projects held an online meeting to discuss how they can work together to maximise the reach and impact of all the projects. As a result of the meeting the group is planning a series of joint activities which will include webinars, workshops and articles. In the next newsletter we will publish more details about these activities, but in the meantime you can find out more about each of the projects below.



#### Innoveas



The Innoveas project is an initiative to build and deliver a capacity building programme, aiming at addressing the major non-technical barriers that most often hamper the adoption the energy auditing practice, in particular among those actors, such as Small and Medium Enterprises where such audits are not required by law. The ultimate goal is to consolidate a structured, permanent and expandable offer to help develop continuous self-sustainable services to raise awareness and build capacity in the field of energy auditing and related energy saving measures in SMEs, especially in the sectors of Food, construction and chemistry.

The project therefore aims at designing and deploying staff trainings and capacity building programmes to enhance corporate policy towards energy efficiency, energy culture and sustainable supply-chain initiatives.

e2Driver



E2DRIVER teaches firms in the automotive industry how to conduct energy audits, increase their energy efficiency and reduce energy-related costs. Through a people-centred approach, the training methodology is adapted to each trainee's needs and ambitions. An innovative learning platform developed in the project facilitates the application of the training, containing training materials, tools and lessons. The platform's strength also lies in the fact that it serves as a hub where trainees can exchange new skills and insights among themselves to collaboratively bridge the knowledge gap on energy audits and energy efficiency.

SMEmPower Efficiency




The objective of the project is to "Empower" SMEs to undergo energy audits and implement their proposals. A holistic methodology has been chosen to address different barriers based on three dimensions, i.e. Individual, Organizational and Institutional. The first concerns the design and delivery of an integrated Education & Training (E&T) programme targeting energy related SME staff and focusing on the financial and technical data required to prove that specific measures are cost-effective. This is connected with the second dimension targeting SME decision makers. In-house short trainings for decision makers of grouped SMEs according to their specificities will be delivered. Finally, the third dimension relates to targeted workshops where both SME decision makers and stakeholders from entities able to finance energy projects will come together and interact based on the real data provided from pilots.

#### The SPEEDIER team moves online!

Due to the Covid-19 travel restriction, the SPEEDIER team was not able to meet in person for their General Assembly meeting on 17<sup>th</sup> June 2020. Instead they met virtually to discuss the project progress and celebrate the achievements of the project in its first 12 months. Project coordinator, Ms Jo Southernwood, was delighted to report that despite the challenges caused by COVID-19 the team has still managed to deliver on its targets to date. Each Work Package leader then presented the progress of their respective work packages and their innovative plans for continued delivery, accounting for the challenges imposed by social distancing and travel restrictions. Many of the planned training activities for SMEs, SPEEDIER Experts and SPEEDIER Trainers will move online, making them more accessible to all. 

# The SPEEDIER Service goes online!

SPEEDIER partner, ITeC, has been very busy over the last few months preparing the SPEEDIER Energy Auditing Tool and we are pleased to announce that a Beta version is now available for testing!


The tool aims to help Energy Experts to carry out an energy audit and make energy saving recommendations for SMEs. The most interesting part of tool is that the energy saving recommendations are categorised and grouped according to the level of investment required. This cost categorisation (no-cost, low-cost, medium-cost and high-cost measures) will help energy experts to guide SMEs through a phased approach to implementing energy saving measures. Starting with no-cost measures allows SMEs to build a up a fund which can be ring-fenced and re-invested into low-, medium-, or high-cost measures.

After entering a few details about the building being audited, (e.g. size, operating schedule, and details of energy consuming equipment), the tool will suggest the most suitable energy saving recommendations for that building, categorised by cost. To make life even easier for the energy experts, the tool also accounts for the local climatic conditions once the building's location is specified. # Average score of Advissory Board Members on SPEEDIER Mobile App




FIGURE 2: SPEEDIER MOBILE APP FEEDBACK ANALYSIS




FIGURE 4: SPEEDIER TRAINING FEEDBACK ANALYSIS

Average Score of Advisory Board Members on Repolication of SPEEDIER in other EU Countries





FIGURE 4: SPEEDIER REPLICATION IN OTHER EU COUNTRIES FEEDBACK ANALYSIS

The SPEEDIER mobile app is ready for SMEs!



SPEEDIER is delighted to announce that the web version of the SPEEDIER mobile app is ready to be used by SMEs. The app is developed by the <a href="International Energy Research Centre">International Energy Research Centre</a>, (IERC) Ireland. IERC team is also developing mobile version of the app (on Android and iOS platforms). The objective of the mobile app is to use it as a remote capacity building tool for developing energy culture and bringing behavioural changes by creating energy efficiency awareness among the SME employees. There will be discrete administrator and user account for each organisation within the app. The Administrator account will be managed by either an internal energy manager of the organisation or by a SPEEDIER Expert who would act as an external energy consultant. The Administrator of each organisation will be responsible for managing user accounts and energy data of their own organisation within the app. The User account will be used by all the employees of the organisation.

In order to encourage user interaction with the mobile app 'Gamification features' have been included, which rewards user with some points for specific activities in the app. The app provides a means for employees to make their energy efficiency and energy management opinion heard within their organisation. The App allows users to provide 'Feedback' about thermal comfort of their work place and a 'Suggestion' regarding possible energy saving opportunities that could be applicable to their organisation. The App has an 'Energy Management' feature which allows users to view their organisation's monthly/annual energy consumption, energy cost, list of energy consuming equipment, and list of energy saving measures as per their cost category along with status of implementation within their organisation. The App also provides a 'Learning' opportunity for employees to gain knowledge about energy efficiency as per their organisation's energy management policy and check their knowledge through a 'Quiz' section.





SPEEDIER at World Sustainable Energy Days 2021





# SPEEDIER energy expert support tool

The <u>SPEEDIER Energy Expert Support Tool</u> is now available on the SPEEDIER website. The tool aims to help Energy Experts to carry out an energy audit and make energy saving recommendations for SMEs. The most interesting part of the tool is that these energy savings recommendations are categorised and grouped according to the level of investment required. This cost categorisation (no-cost, low-cost, medium-cost and high-cost measures) will help energy experts to guide SMEs through a phased approach to implementing energy saving measures. No-cost measures allow SMEs to build up a fund which can be ring-fenced and re-invested into low-, medium-, or high-cost measures.

After entering a few details about the building being audited, (e.g. size, operating schedule, and details of energy consuming equipment), the tool will suggest the most suitable energy saving recommendations for that building, categorised by cost. To make life even easier for the energy experts, the tool also accounts for the local climatic conditions once the building's location is specified. Click here to find the instructions
